#### Additional Notes:

1. The policy includes “Extended Contractual Liability” cover in relation to standard Oil & Gas Industry contracts/”Hold Harmless” agreements, which includes naming of contract principals as additional insureds & waiving rights of subrogation against them.

This cover is offered on a “blanket” basis only, with no customer-specific certificates being available. The “trigger” for activating this cover is the existence of a contract that requires it.

2. Insurers will not provide advance written notice of cancellation/non-renewal/material reductions in cover to any party, other than provision of advance notice of cancellation to the Policyholder Companies at their last recorded address, as provided for within the policy document.
3. Under the Employers Liability section, cover is specifically excluded in relation to any Workers Compensation Scheme or similar employee injury-based regulations/legislation.
4. The business declared to insurers and covered under the policy is –

**“Design, manufacture, maintenance and operation of oilfield drilling waste processing equipment and services. Waste management, recycling, collection and disposal. Plant Hire. Tank cleaning. Fabrication, maintenance, hire and supply of associated equipment. Property owners.”**
